II. BRIEF CAREER

Dr. Sok is a practicing attorney and the Managing Partner at SokSiphana&associates/a Member of Zicolaw, a law and consulting firm specialized in international trade, corporate and banking law in Phnom Penh.

Dr. Sok was appointed by Prime Minister Samdech Techo Hun Sen to hold concurrently the position as Advisor of the Royal Government of Cambodia, as Advisor to the Supreme National Economic Council (SNEC), and as Advisor to the Council for Development of Cambodia (CDC) with rank of Minister in August 2009 and November 2011 respectively.

Previously from 1999 to 2005, Dr Sok served as Secretary of State at the Ministry of Commerce, where he worked extensively on issues related to trade policies and development, commercial legal framework and economic integration. During his service at the Ministry, he was also a negotiator in Cambodia's accession to the World Trade Organization (WTO). From October 2005 to July 2009 he served as Director at the International Trade Center (ITC) a joint technical agency of the UNCTAD and the WTO in Geneva, Switzerland.

Trade Policy experiences: Dr. Sok has unique experiences and insights related to the development of the Cambodian legal system, the business environment and the intricacy of the commercial and investment law evolution in Cambodia. His vast hands on experiences as a former Commerce Secretary of State in the Cambodian Government, where he worked extensively on issues related to commercial and investment legal framework, trade promotion, trade policies, trade development, and economic integration, gives him a unique perspective on both the macro and micro needs of businesses and foreign investors alike. In the area of policy formulation and policy mainstreaming he was responsible for leading a large multidisciplinary inter-agency task force to prepare complex action plans (including the National Legislative and Regulatory Agenda) and to negotiate successfully Cambodia's accession to the WTO. He was also instrumental in initiating the development of the first ever trade Sector Wide Approach (SWAp) for Cambodia. He was responsible not only for the preparation of the various commercial laws currently in force in Cambodia, but also for their defense in front of the Council of Ministers, the National Assembly and the Senate.

Corporate law experiences: Dr. Sok has provided comprehensive advice on domestic and offshore financing matters, structuring for bank capital requirements and asset financing.
